International investment law is perhaps one of the most neglected area of international law, as acknowledged by the International Court of Justice. The absence of international treaties regulating international investments has caused numerous states to enter into bilateral investment treaties ("BITs") among themselves to outline the protection available to foreign investors. Some of these BITs have been interpreted to give protection beyond what is given under customary international law. The objective of this seminar is to introduce international investment law, and the rights and protection available. With globalisation, this area of law is now becoming increasingly important.

The seminar will cover the following:

- the nature and sources of international investment law;
- general principles of international investment law;
- understanding bilateral investment treaties; and
- how international investment disputes are resolved.

### About the Speaker

**Srimurugan Alagan** is an advocate and solicitor admitted to the High Court of Malaya in 2003. Srimurugan completed his LLM with the University of London, specialising in international dispute resolution. He has academic and practical experience in national and international areas of law.
