The Bar Council Advocacy Training Committee is organising an advanced-level advocacy training course on appellate and written advocacy. The objective of the course is to provide participants with practical insight and suggestions for improving their written / outline submissions on appeal, and making an effective oral argument before an appellate tribunal.

This course follows the same effective and successful training method deployed for the basic advocacy training course also organised by the Bar Council Advocacy Training Committee. The course is based on two case studies that participants will be expected to prepare for and then perform in real court settings. Participants will be expected to fully prepare for oral arguments and to file written / outline submissions in advance.

The trainers include Judges of the Court of Appeal and experienced Members of the Bar. The trainers will provide practical and helpful pointers in a positive and professional environment, with the aim of assisting participants to:

- (a) present clear, concise and comprehensive written work;
- (b) develop clear and persuasive appellate arguments; and
- (c) engage effectively with the appellate tribunal.

This course is recommended for Members of the Bar with at least five years of experience in practice, who wish to refine their skills in relation to appellate work. Prior attendance and completion of the basic advocacy training course is strongly recommended but not essential.

Places are limited to **30 participants for each session** and will be given on a first come, first served basis. Members are, nonetheless, encouraged to register their names as it is intended that the course will be organised regularly for the benefit of Members.
