No Sijil Annual / Practising Certificate will be issued to an advocate and solicitor in the event of failure to remit the required payments. It is an offence to practise without a valid Practising Certificate.

We would like to draw your attention to section 36(1) of the LPA, which reads as follows:

Subject to this section, no person shall practise as an advocate and solicitor or do any act as an advocate and solicitor unless his name is on the Roll and he has a valid practicing [*sic*] certificate authorizing him to do the act; a person who is not so qualified is in this Act referred to as an "unauthorized person".

We would also like to draw your attention to sections 44, 46(5) and 46(6) of the LPA, which read as follows (emphases added):

- Section 44 All members who are not in arrears with their subscription under section 46 shall be eligible—

 (a) to attend and vote at any general meeting;
 (b) subject to section 46A, to be elected to the Bar Council; and
 (c) to vote on the election of members to the Bar Council.

 Section 46(5) Liability to pay any annual subscription to the Malaysian Bar shall arise when the subscription has been fixed by the Bar Council. All annual subscriptions to the Malaysian Bar shall be paid by the <u>30th</u> day of June of each year.
- Section 46(6) An advocate and solicitor shall, if he pays his annual subscription after the date mentioned in subsection (5), pay to the Bar Council, in addition to the subscription due, <u>an amount equivalent</u> to the subscription so due.

Please note that the deadline for payment of the annual subscription, as provided in the LPA, must be strictly adhered to, and no application for waiver of penalty will be entertained. If you fail to pay by the deadline, you will have to pay an additional sum of RM450.

Frequently-Asked-Questions 2019 Malaysian Bar Payments Required under the Legal Profession Act 1976

The issuance of a Sijil Annual / Practising Certificate is subject to full payment of all required amounts. Practising Certificates are generally valid from 1 January (or the date of issue) to 31 December of each respective year.

(1) When is the annual subscription due?

We would like to draw your attention to sections 44, 46(5) and 46(6) of the Legal Profession Act 1976 ("LPA"), which read as follows (emphases added):

- Section 44 All members who are not in arrears with their subscription under section 46 shall be eligible—

 (a) to attend and vote at any general meeting;
 (b) subject to section 46A, to be elected to the Bar Council; and
 (c) to vote on the election of members to the Bar Council.

 Section 46(5) Liability to pay any annual subscription to the Malaysian Bar shall arise
 - when the subscription has been fixed by the Bar Council. All annual subscriptions to the Malaysian Bar shall be paid by the <u>30th day of June of</u> each year.
- Section 46(6) An advocate and solicitor shall, if he pays his annual subscription after the date mentioned in subsection (5), pay to the Bar Council, in addition to the subscription due, **an amount equivalent** to the subscription so due.

(2) Can the penalty incurred due to late payment be waived?

The deadline for payment of the annual subscription must be strictly adhered to, and no application for waiver of penalty will be entertained.

(3) What are the payments that I am required to make?

The annual subscription is in the sum of RM450 for the period from 1 January to 31 December of each year.

(7) Can the required payments be paid in instalments?

The required amounts must be paid in full by the stipulated due date. There is no provision for deferred or periodic payment.

(8) What are the consequences of failure to remit the required payments?

The issuance of a Sijil Annual / Practising Certificate is dependent on full payment of all required amounts. No Sijil Annual / Practising Certificate will be issued to an advocate and solicitor in the event of failure to remit the required payments. It is an offence to practise without a valid Practising Certificate.

We would like to draw your attention to section 36(1) of the LPA, which reads as follows:

Subject to this section, no person shall practise as an advocate and solicitor or do any act as an advocate and solicitor unless his name is on the Roll and he has a valid practicing [*sic*] certificate authorizing him to do the act; a person who is not so qualified is in this Act referred to as an "unauthorized person".

(9) If I only require a Practising Certificate for a certain period in a year, can a discount or refund be obtained?

An advocate and solicitor who resumes practice before 1 July of any year must pay the full amounts, as there is no provision for a discount or a refund. An advocate and solicitor who resumes practice from 1 July to 31 December (inclusive) of any year is required to pay RM50 (instead of RM100) towards the Compensation Fund. All other required amounts must be paid in full.

(10) An advocate and solicitor had been issued with Sijil Annual 2019. He ceased practice on 15 Jan 2019. Is he required to pay the 2019 annual subscription and levies, totalling RM920?

Yes. As long as he practised as an advocate and solicitor during the year 2019, even for one day, he is required to pay the 2019 annual subscription and levies, totalling RM920.

(11) An advocate and solicitor had ceased practice in April 2019. As she did not pay the 2019 annual subscription by the due date, a penalty was imposed. She then resumed practice in November 2019. Can the penalty be waived?

As long as she practised as an advocate and solicitor during the year 2019, even for one day, she is required to pay the 2019 annual subscription and levies, totalling RM920. Furthermore, the penalty cannot be waived.

(12) An advocate and solicitor had been issued with Sijil Annual 2019. She ceased practice on 15 Dec 2018. Is she entitled to a refund of the Compensation Fund and Discipline Fund payments for 2019 or can these be transferred to the following year when she resumes practice?

Once Sijil Annual 2019 is issued, there will be no refund of the 2019 Compensation Fund and Discipline Fund payments, and the amounts cannot be transferred to the following year.
