The Bar Council Human Rights Committee (“HRC”) is organising a monitoring team to observe the “Goods and Services Tax (“GST”) — Protest till it is Dropped” Rally organised by the May 1 Committee, scheduled to take place in Kuala Lumpur on 1 May 2014 (Thursday).
