Malaysian Bar Legal Market Visit to London (29 and 30 June 2016)

Following the success of this programme in 2014, the Bar Council is once again collaborating with the Law Society of England and Wales ("LSEW") to organise a legal market visit to the United Kingdom ("UK") for Members of the Malaysian Bar on 29 and 30 June 2016 (Wednesday and Thursday).

The visit coincides with the Capital Markets in the European Union Conference ("Conference") organised by LSEW, which will be held on 28 June 2016 (Tuesday). Members of the Malaysian Bar delegation who wish to attend the Conference can click here for details on how to register, and the pricing schedule for the Conference.

The visit is specifically designed to provide Malaysian lawyers — particularly commercial law practitioners — networking opportunities for international business development, with representatives of UK companies as well as investors and legal professionals from the UK. This will provide a unique opportunity for delegation members to meet and exchange experiences with the UK participants.

There is no participation fee for the legal market visit. Participants pay their own costs, including for international and local travel, accommodation, and other incidental expenses. Travel bookings should only be made following confirmation of participation.

The sessions with LSEW will include the following:

- (1) Session on doing legal business in England and Wales, and the Qualified Lawyers Transfer Scheme;
- (2) Session with a panel of London-based Malaysian lawyers on first-hand experiences of working in England and Wales;
- (3) Seminar on developing international legal business in these areas:
 - Business or profession;
 - Commercial awareness; and
 - Social media skills; and
- (4) Presentation on key market developments.




