The Advocacy Training Course ("ATC"), organised by the Bar Council Professional Standards and Development Committee, is primarily aimed at improving the standards of advocacy and producing better advocates.

The ATC is designed to teach the basics of advocacy by utilising the Hampel method of advocacy teaching, which requires participants to perform as advocates in a simulated courtroom environment under the guidance of experienced and trained practitioners, who will observe their performance and offer guidance. It identifies and rectifies basic mistakes in advocacy, and offers guidance to new practitioners on the correct way to present themselves and their arguments in a courtroom. This method is similar to that employed in the Bar Professional Training Course (previously the Bar Vocational Course) in the United Kingdom.

The ATC is best suited for lawyers in their first to third years of practice, and Members with little advocacy experience.
