Malaysian Bar-Korean Bar Association Young Lawyers Exchange Programme 2016

The Bar Council is organising the Malaysian Bar-Korean Bar Association Young Lawyers Exchange Programme ("YLEP") 2016, which will take place in November 2016. YLEP 2016 is in its second instalment this year, after having been successfully piloted in 2014.

YLEP 2016 is an exchange programme for young lawyers from both Malaysia and South Korea, where eligible Members of the Malaysian Bar will be hosted by South Korean law firms for two weeks, commencing on 10 Nov 2016 (Thursday).

Separately, Malaysian law firms will host participants from South Korea for a similar duration, beginning on 14 Nov 2016 (Monday).

Eligibility

Any Member of the Bar who has fewer than seven years of practice (as at 30 Nov 2016) is eligible to participate in YLEP 2016, regardless of whether the Member's law firm participates as a host firm.

A law firm that is active and based in Peninsular Malaysia may either host participant(s) from South Korea and/or register its lawyer(s) as participant(s) in Seoul. There is no limit to either the number of South Korean participants hosted by the firm, or the number of its lawyers who sign up as participants.

Brief Overview

In addition to placements in selected South Korean firms, official visits to the courts and other government agencies will be organised for participants from the Malaysian Bar, who will also be involved in projects conducted and hosted by the Korean Bar Association. A detailed programme will be provided to the participants.

Cost

Each Member of the Bar is expected to pay for the costs incurred throughout the duration of the programme, including for international and local travel, accommodation, and incidental expenses in South Korea.

The cost for Malaysian host law firms is expected to be minimal, as South Korean participants will in turn bear their own costs.





Bar Council Subsidy

Participants who wish to be considered for a subsidy from the Bar Council must complete Section 5 of the attached application form. Each successful candidate (up to a maximum of five participants) will receive a subsidy of RM1,000 to help defray the expenses for YLEP 2016.

The selection of participants for the Bar Council subsidy will be based on merit. The decision of the Bar Council's selection committee, chaired by the Vice-President of the Malaysian Bar, George Varughese, is final.

Any Member who does not receive the subsidy is welcomed to participate in YLEP 2016 at the Member's own cost.
