About the Speaker

Datuk Seri Gopal Sri Ram was called to the Malaysian Bar in May 1970 and practised law until his elevation to the Court of Appeal in September 1994. He is the first practitioner in Malaysia to be elevated directly to an appellate court. On 15 Apr 2009, he was elevated as a judge of the Federal Court of Malaysia. He retired on 16 Feb 2010. He is an Honorary Bencher of Lincoln's Inn.
