Joint Forum between the Korean Bar Association and the Malaysian Bar (5 July 2013)

The Bar Council will host a delegation from the Korean Bar Association. The purpose of the visit, amongst others, is to sign the extension to the Memorandum of Understanding ("MOU") between the Malaysian Bar and the Korean Bar Association to foster a positive and mutually beneficial relationship between both parties.
