Wong Sai Fong was previously the Managing Partner of Messrs Shearn Delamore & Co. He is now a Senior Partner of the firm and is the Joint Head of the firm's Intellectual Property Practice Group. He was called to the Malaysian Bar in 1980 and the Singapore Bar in 1993. He practises exclusively in all litigation, enforcement and advisory aspects in the field of IP law.

Michael Soo is Head of the Intellectual Property and Information Technology Department of Messrs Shook Lin & Bok. He was the past President of the Malaysia Intellectual Property Association ("MIPA"), is currently the President of the Asian Patent Attorneys Association, Malaysia Country Group, and a Councillor of the Asian Patent Attorneys Association. He was a member of the Copyright Law Review Ad-hoc Committee, under the Attorney General's Chambers, Malaysia. He has practised exclusively in all areas of IP law, with emphasis on enforcement and civil litigation, for over 30 years. Michael Soo was listed under the Legal 500 Asia Pacific 2014 as a recommended lawyer in the area of IP law.

Kuek Pei Yee is a Partner in the Intellectual Property Division of Messrs Skrine. Her work focuses mainly on advising and representing clients in disputes relating to patents, trade mark, industrial designs, copyright, privacy and trade secrets, as well as various aspects of enforcement of IP rights. Over the years, she has represented many multinational and domestic companies in litigation and IP enforcement matters.
