Jeremy M Joseph is principal partner and founder of Messrs Joseph & Partners. He has a Master's degree in maritime law from the University of Southampton, and received a Chevening Scholarship from the British High Commission. He is one of the foremost experts in maritime law in Malaysia.

Originally a marine insurance broker, Jeremy M Joseph has vast knowledge of the shipping insurance industry. His first position in law was at the Singapore office of Messrs Holman Fenwick & Willan, where he worked as an associate for several years until he set up Messrs Joseph & Partners in Kuala Lumpur in 2002. The firm soon garnered a reputation for maritime law expertise, and has been acknowledged by Legal 500 and Chambers Asia in 2009, 2010 and 2011 as a leading shipping law legal firm in Malaysia. Jeremy M Joseph also won the Corporate International UK's Malaysia Shipping Lawyer of the Year Global Awards 2011. He works as counsel and co-counsel in various shipping, insurance and Malaysian maritime arbitration matters, and advises on a variety of organisations, from ship owners and P & I Clubs to insurers, banks and charterers.

He has also authored numerous articles for Malayan Law Journal and the Halsbury's Laws of Malaysia *Shipping, Insurance and Carriers* series. He is a former Chairperson of the Bar Council Shipping and Admiralty Committee, and served in the Admiralty Court and Maritime Law Taskforce initiated by the Chief Justice and the Maritime Arbitration Working Committee initiated by the Kuala Lumpur Regional Centre for Arbitration.
