This generation is the main propagator of User-Generated-Content ("UGC"), wherein the members tweet, update their Facebook status, post up pictures, and record and upload practically everything in real time. To the Facebook Generation, the Internet is not a luxury but instead a necessity of life.

However, in recent times, governments across the globe have attempted to shackle UGC by introducing laws aimed at directly or indirectly regulating content that is uploaded. In Malaysia for example, amendments recently made to the Evidence Act 1950 put in place a presumption that renders a user liable for a mere Facebook status update made via the user's account, regardless of whether the update originated from the user or someone else.

This forum will examine:

- (1) The advent of the Facebook Generation;
- (2) Changes in the social media landscape;
- (3) Attempts to regulate the Internet and social media locally and abroad (ie Stop Online Piracy Act ("SOPA") and Children's Internet Protection Act ("CIPA") in USA, section 114A of the Evidence Act 1950 in Malaysia, outright ban of Twitter and Blackberry Messenger ("BBM") in the Middle East); and
- (4) How the Facebook Generation around the world has reacted to such attempts at regulation.
