The Bar Council Membership Department is pleased to present our annual workshop on completing the Sijil Annual and Practising Certificate application and PII Proposal Form, on **5 Oct 2016 (Wednesday)**.

Every year, the Membership Department undertakes the task of checking thousands of applications, and we look forward to your cooperation in making sure that your application is in order. A well-prepared application will expedite the processing time, ensuring that your Sijil Annual and Practising Certificate 2017 are issued promptly.

This workshop, which will be conducted by a team of officers from the Membership Department, provides you with an opportunity to equip yourself with basic knowledge and tips on completing your application.

The documents will be pre-filled with each lawyer's details, thus simplifying the process of completing the forms.

Managers, office administrators or clerks of law firms who are responsible for the preparation of their lawyers' Sijil Annual and Practising Certificate applications and their firms' PII Proposal Forms, are strongly encouraged to attend the workshop.
