Please allow up to 48 hours for your registration to be processed.
  - Next, click **here** to download the ProView app on your preferred device (Windows or Mac desktop / laptop, Android tablet or iPad). An internet connection is required to download the app and *Legal Craft & Such* for the first time. After the download, you can access ProView and its content so you can read on the go! Then, click on the ProView app icon to log in using your OnePass account. Future editions of *Legal Craft & Such* will appear in your library.
- ProView can also be accessed directly from your browser using your OnePass account . Click **here** to login from your browser.
