The documents will be pre-filled with each lawyer's details, thus simplifying the process of completing the forms.

Managers, office administrators or clerks of law firms who are responsible for the preparation of their lawyers' Sijil Annual and Practising Certificate applications, are strongly encouraged to attend the workshop.
