About the Speakers

Dato' V Sithambaram, Sole Proprietor, Messrs Sitham & Associates

Dato' V Sithambaram graduated with a degree of Utter Barrister at The Honourable Society of Lincoln's Inn, London, and was called to the English Bar in 1978. He was admitted to the Malaysian Bar in 1979.

He began his legal practice as a criminal lawyer, and established himself by appearing in numerous criminal cases at the High Court, Court of Appeal and Federal Court.

He was the past Chairman of the Penang Bar Committee, and was a Bar Council member. He is presently the Co-Chairperson of the Bar Council Criminal Law Committee.

Dato' V Sithambaram was an Adjunct Professor of Law at University Utara Malaysia ("UUM"), and an Honorary Assistant Commissioner of Police.

Dato' Dr Bhupinder Singh, Senior Consultant Forensic Pathologist, Department of Forensic Medicine, Penang Hospital

Dato' Dr Bhupinder Singh is a forensic pathologist behind many high-profile cases. Among his most memorable cases was one that involved five exhumed skeletal remains belonging to Sio Sam Ong (Three Little Emperors) triad members in 1992. He was also a member of the Royal Commission of Inquiry instituted to look into the death of Teoh Beng Hock in 2011.

He is the Past President of the Indo-Pacific Association of Law, Medicine and Science (2013–2016), and a member of the Scientific Advisory Board of the Office of the Prosecutor of the International Criminal Court, The Hague (2014–2016).

Amidon Anan, Former Head of Crime Scene, Royal Malaysia Police

Amidon Anan has served the Royal Malaysia Police for 34 years, and was involved in high-profile cases such as the murders of Canny Ong and Altantuya Shaariibuu, and the Anwar Ibrahim sodomy trial. He has also given expert testimonies for more than 1,000 cases in Malaysia.

He has had teaching experience, among others, in Institut Latihan Kehakiman dan Perundangan ("ILKAP"), Royal Malaysia Police College Kuala Lumpur and Kuala Kubu Baru, and the Law Faculty in University Technology Mara ("UiTM") and International Islamic University Malaysia ("IIUM") since 2005.

He was awarded Darjah Pahlawan Pasukan Polis in 2007.
