Amir Bahari



Amir Bahari obtained a Masters of Comparative Laws degree and a Postgraduate Diploma in Syariah and Legal Practice from International Islamic University Malaysia ("IIUM"). His areas of practice cover mainly Islamic estate planning (including *wasiyyah* and *hibah*), Islamic family law, Islamic estate distribution and legal negotiation.

For the past three years, he has been actively giving talks organised by the Bar Council, the State Bar Committees, Advocates' Association of Sarawak and Sabah Law Association. He practises in three jurisdictions, namely the civil court, and the Syariah court in the Federal Territories and Selangor.

He was a member of Kuala Lumpur Bar Committee from 2013 to 2015 as the Conveyancing Chairperson for the Corporate and Conveyancing Practice Committee.

He is a certified trainer under the Malaysian Institute of Management-Pembangunan Sumber Manusia Berhad ("MIM-PSMB") and a MasterClass Trainer from Billy Kueek International. He has written four books, including one on Islamic wills (published by Telaga Biru), and one entitled *Islamic Estate, Retirement and Waqf Planning* (published by IBFIM).

Mukhtar b Abdullah graduated with a Bachelor of Laws (Hons) degree from IIUM in 1991, and was admitted as an advocate and solicitor in the High Court of Malaya in 1992.

Prior to practising, he served the Terengganu State Economic Development Corporation as an Executive Officer (1980 to 1992) and then as a Legal Officer (1992 to 1996). He left his position on 10 Aug 1996, and joined Messrs Zamani Mohammad & Co as a legal assistant, and was subsequently admitted as a partner in 2002.

He is also a licensed Syarie counsel in Terengganu and has 20 years of experience, in both civil and Syariah matters.

He is a returning member of the Terengganu Bar Committee, and formerly the Terengganu Bar Representative on the Bar Council (2009 to 2013). During his tenure as a member of the Bar Council, he was appointed as the Co-Chairperson of the Bar Council Jawatankuasa Bahasa Melayu and the Bar Council LawCare Committee.

He was a lecturer at the Law Faculty of Universiti Sultan Zainal Abidin (formerly known as KUSZA) from 1991 to 2002, and at present, he is regularly invited by various non-governmental organisations in Terengganu to give talks on women's rights under Syariah law.
