### **E-Filing Documents under Code 08 for Court of Appeal and Federal Court**

We note from the Courts' e-filing portal (<http://efiling.kehakiman.gov.my/eFiling/>) that from 24 Sept 2014 onwards, filers can do online submission for all documents under Code 08 (Notice of Motion for Leave to Appeal) at the Court of Appeal and the Federal Court of Malaysia.

Apart from notices of motion and affidavits, parties can now file letters, notices of discontinuance and other notices, submissions, draft orders, and final orders for Code 08, online. Members of the Bar are encouraged to file these documents via online filing. Nevertheless, hard copies of relevant documents are still required for hearing purposes.

No service bureau charges are being imposed for the time being.

Solicitors are encouraged to file these documents via online filing. Nevertheless, for hearing purposes, hardcopies of relevant documents are still required. As such, if service bureau assistance is needed, service bureau charges will not be imposed until further notice and softcopy via CD/DVD is preferable.
