- ◆ Assistant Trade Commissioner (Investment) in London;
- ◆ Director for MIDA New York; and
- ◆ Director for Foreign Investment Promotion for the Americas.

Currently, he serves MIDA in the capacity of Senior Director (Investment) where he is responsible for promoting foreign direct investment for domestic and cross-border investments.



Sundra Rajoo is currently the Director of the Kuala Lumpur Regional Centre of Arbitration ("KLRCA").

Widely respected, he is a Fellow of the Chartered Institute of Arbitrators, Malaysian Institute of Arbitrators, Singapore Institute of Arbitrators and the Indian Council on Arbitration. He is the first Malaysian to be admitted as a member of the Academy of Experts in England.
