76TH ANNUAL GENERAL MEETING OF THE MALAYSIAN BAR

// The need for continuous legal training is not unique to judges; it is essential for lawyers at the Bar and in public service. In the case of the former, the Bar only recently implemented the Continuing Professional Development ("CPD") programme aimed at enhancing legal knowledge among its members. However, there is a need for greater emphasis on continuous legal education. That too, in relation to the core values underlying the administration of justice. //

## SUMMARY OF THE MALAYSIAN BAR'S MANDATORY CONTINUING PROFESSIONAL DEVELOPMENT ("CPD") SCHEME

19 Mar 2016 **70<sup>th</sup> AGM**  Resolution adopted at the 70<sup>th</sup> Annual General Meeting of the Malaysian Bar ("AGM") making the CPD Scheme mandatory for Members, to take effect on a staggered basis. With effect from 1 July 2016, Members admitted as advocates and solicitors of the High Court of Malaya from 1 July 2011 onwards, are required to obtain 16 CPD points in each 24-month CPD cycle, and pupils in chambers who commenced their pupillage from 1 July 2016 onwards, are required to obtain 8 CPD points in the course of their pupillage.

The first mandatory CPD cycle for the Scheme was from 1 July 2016 until 30 June 2018 (inclusive).

17 Mar 2018 **72<sup>nd</sup> AGM**  Resolution adopted to extend the mandatory CPD Scheme to Members admitted as advocates and solicitors of the High Court of Malaya from 1 July 2006 to 30 June 2011. With effect from 1 July 2018, these Members are required to obtain 16 CPD points in each 24-month CPD cycle.

The second mandatory CPD cycle for the Scheme was from 1 July 2018 until 30 June 2020 (inclusive).

14 Mar 2020 **74<sup>th</sup> AGM**  A motion to extend the application of the staggered mandatory CPD Scheme to Members admitted as advocates and solicitors of the High Court of Malaya between 1 July 2001 and 30 June 2006 with effect from 1 July 2020, was to have been tabled at the 74<sup>th</sup> AGM. However, in light of the health concerns arising from the COVID-19 pandemic, the motion was withdrawn in order to expedite the conduct of the AGM, with the intention that an appropriately amended motion be tabled for a subsequent general meeting of the Malaysian Bar.

The current (ie third) mandatory 24-month CPD cycle for the Scheme is from 1 July 2020 until 30 June 2022 (inclusive).

13 Mar 2021 **75<sup>th</sup> AGM**  Resolution adopted to extend the mandatory CPD Scheme to Members admitted as advocates and solicitors of the High Court of Malaya between 1 July 2001 and 30 June 2006. With effect from 1 July 2021, these Members are required to obtain 8 CPD points for a 12-month period from 1 July 2021 to 30 June 2022 (inclusive), and 16 CPD points during each subsequent 24-month CPD cycle.






