**Remand Applications During the Movement Control Order**

We refer to [Circular No 063/2020](#) entitled “Update on COVID-19 | Movement Control Order (II)” dated 17 Mar 2020, and to the Movement Control Order (“MCO”) issued under the Prevention and Control of Infectious Diseases Act 1988 and the Police Act 1967 as announced by the Prime Minister on 16 Mar 2020, as well as [Circular No 076/2020](#) entitled “Update on COVID-19 | Movement Control Order (IV): Problems Faced by Members” dated 26 Mar 2020.

The Chief Registrar of the Federal Court, Tuan Ahmad Terrirudin bin Mohd Salleh, has extended to us a notification entitled “Permohonan Bantuan Reman Oleh Majistret / Pendaftar Mahkamah Di Balai-Balai Polis Seluruh Malaysia Sepanjang Tempoh Perintah Kawalan Pergerakan”, today.

The notification states that all remand applications during the duration of the Movement Control Order will be conducted at all police stations throughout Malaysia.

Dengan segala hormatnya perkara di atas adalah dirujuk dan surat YDH Dato’ Pahlawan DIG’ bertarikh 1 April 2020.

2. Adalah saya diarahkan oleh YAA Tan Sri Tengku Maimun binti Tuan Mat, Ketua Hakim Negara untuk memaklumkan bahawa YAA Tan Sri bersetuju dengan permohonan pihak YDH Dato’ Pahlawan DIG agar semua permohonan reman sepanjang tempoh Perintah Kawalan Pergerakan (PKP) ini didengar di Balai-Balai Polis Seluruh Malaysia. Walau bagaimanapun, kerjasama pihak YDH Dato’ Pahlawan DIG adalah dipohon untuk mengambil maklum perkara-perkara berikut—

- (iii) Hak Orang Yang Disyaki (OYDS) untuk diwakili Peguam adalah tidak dinafikan; dan
- (iv) Mematuhi Garis Panduan Pengurusan COVID-19 yang dikeluarkan oleh Kementerian Kesihatan Malaysia (KKM) dari semasa ke semasa.
