Notification of Case Hearings Conducted Online during the MCO Period

We refer to [Circular No 063/2020](#) entitled “Update on COVID-19 | Movement Control Order (II)” dated 17 Mar 2020, the Movement Control Order (“MCO”) issued under the Prevention and Control of Infectious Diseases Act 1988 and the Police Act 1967 as announced by the Prime Minister on 16 Mar 2020 and all extensions of the MCO period announced thereafter, [Circular No 076/2020](#) entitled “Update on COVID-19 | Movement Control Order (IV): Problems Faced by Members” dated 26 Mar 2020, and [Circular No 077/2020](#) entitled “Update on COVID-19 | Hearings to be Conducted Online During the Movement Control Order” dated 26 Mar 2020.
