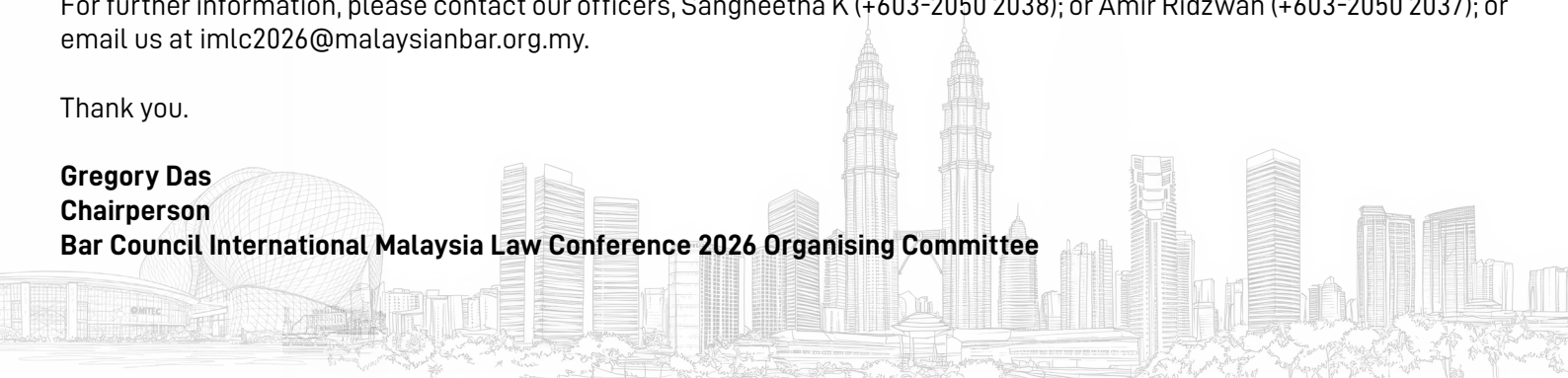
Additional sponsorship platforms — including social events — offer further avenues for organisations to showcase their brand and engage with conference participants.
