**Resolution Regarding the Provision of Legal Research Products from CLJ Legal Network Sdn Bhd, The Digital Library Sdn Bhd, and Thomson Reuters Asia Sdn Bhd**

We refer to [Circular No 089/2025](#) issued on 17 Mar 2025 in which we informed Members about the [resolutions adopted at the 79<sup>th</sup> Annual General Meeting of the Malaysian Bar held on 15 Mar 2025](#).

We thank Members for their support of the motion regarding the provision of legal research products from CLJ Legal Network Sdn Bhd, The Digital Library Sdn Bhd, and Thomson Reuters Asia Sdn Bhd. The adoption of this motion allows Members to enjoy the use of these legal research products at very affordable rates.

Please take note of the following:

- (1) Members of the Malaysian Bar have been enjoying access to these three legal research products since July 2022, pursuant to a Resolution adopted at the 76<sup>th</sup> AGM on 19 Mar 2022;
- (2) The current Service Agreements with these providers will expire on 30 June 2025;
- (3) The motion regarding the Provision of the Legal Research Products from CLJ Legal Network Sdn Bhd, The Digital Library Sdn Bhd, and Thomson Reuters Asia Sdn Bhd, was carried at the 79<sup>th</sup> AGM of the Malaysian Bar; and
- (4) We are working towards finalising the new Service Agreements so that Members will have continued access on 1 July 2025. In this regard, Members will need to pay the Legal Research Levy for 2025 (pro-rated), 2026, 2027 and 2028 (pro-rated) in due course.
