**Malaysia Bar Professional Indemnity Insurance Scheme
JLT amalgamation into Marsh Insurance Brokers effective 1st Aug 2020**

As mentioned previously including via email of 13 May 2020, Jardine Lloyd Thompson Sdn Bhd (JLT), the insurance broker for the Malaysian Bar Professional Indemnity Insurance (PII) Scheme, had become a member of the Marsh & McLennan Companies (MMC Group) since 1st April 2019.

Therefore JLT's business will be transferred to Marsh Insurance Brokers (Malaysia) Sdn. Bhd. as a result of this amalgamation. The court has issued the vesting order which shall take effect from 1st August 2020

Therefore for all future correspondence and documents, all references to JLT shall be replaced with "Marsh Insurance Brokers (Malaysia) Sdn. Bhd". (Marsh) with the appropriate Marsh Logo.
