CIRCULAR NO. 74 of 2020

**GUIDELINES IN RESPECT OF THE CONDUCT OF CASES AT THE MELAKA COURTS
DURING THE CONDITIONAL MOVEMENT CONTROL ORDER
FROM 9 NOVEMBER 2020 UNTIL 6 DECEMBER 2020**

We refer to Bar Council Circular No. 391/2020 dated 8 November 2020 and the media statement issued by the Chief Registrar of the Federal Court of Malaysia entitled “*Pemakluman Pengendalian Kes-Kes Di Mahkamah Negeri Terengganu, Negeri Sembilan, Johor, Perak, Kedah, Pulau Pinang Dan Melaka Selaras Dengan Perintah Kawalan Pergerakan Bersyarat (PKPB) Dan Di Mahkamah-Mahkamah Negeri Selangor, Wilayah Persekutuan Kuala Lumpur Dan Wilayah Persekutuan Putrajaya Selaras Dengan Sambungan PKPB Dari 9 November Hingga 6 Disember 2020*”.

As all cases (civil and criminal) which will be heard physically from 9 November 2020 to 6 December 2020 will be postponed, the Melaka Courts have come up with the following arrangements:-

- **Melaka, Jasin and Alor Gajah Lower Courts**

All cases which will be heard physically from 9 November 2020 to 6 December 2020 at the Lower Courts will be postponed. However, for the remand cases and fresh charge cases will be conducted as usual in the Melaka Court Complex.

We will update members once we receive the new cause list from the Melaka, Jasin and Alor Gajah Courts.

Members who have any inquiries regarding their matters in Melaka, Jasin and Alor Gajah Court are advised to email to the respective court’s interpreters and their email address is attached [here](#) for your attention.

In respect of matters before the **Malacca Magistrate’s Court 1** (Puan Lee Kim Keat), the following arrangements have been made:-

- All civil cases from 9 November 2020 to 6 December 2020 will be converted to E-Review.
- For all JPJ Summons and Traffic Summons from 9 November 2020 to 6 December 2020, the Court will fix new dates.
- Members who have any inquiries regarding their matters are advised to email taypohchoo@kehakiman.gov.my (Puan Alicia) or manochitra@kehakiman.gov.my (Puan Monachitra).

- **Melaka High Court Senior Assistant Registrars' Cases**

For cases before the High Court Senior Assistant Registrars, namely Puan Analia Binti Kamaruddin, Tuan Muhammad Hidayat Bin Wahab and Tuan Mohd Firdaus Bin Saleh, the Court will issue a Notice in Form 59 through the e-filing system to the respective lawyers to inform them of the new dates.

- **E-Review Matters (High Court and Lower Courts)**

All E-Review matters will be conducted as usual. The Registrars of the Melaka Courts will attend to the E-Review.

- **Auction matters**

For Auction matters, the Court will cancel the dates fixed from 9 November 2020 to 6 December 2020. Lawyers who have client's instructions to request for new dates for auction matters are required to file in a Notice of Application to request for a new date.

- **E-Lelong**

Hearings of Notices of Application to obtain an E-lelong order which have been fixed from 9 November 2020 to 6 December 2020 will be vacated, and new dates will be informed through the e-filing system.

For E-Lelong conducted by Pusat Operasi E-Lelong, the E-lelong will be conducted as usual.

In the event, if members would like to request for postponement of the E-Lelong, members are required to e-file a letter to the Pusat Operasi E-Lelong.

- **Melaka High Court cases before the Judges, and applications filed by way of Certificate of Urgency and other urgent matters.**

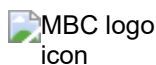

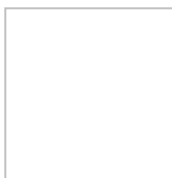
